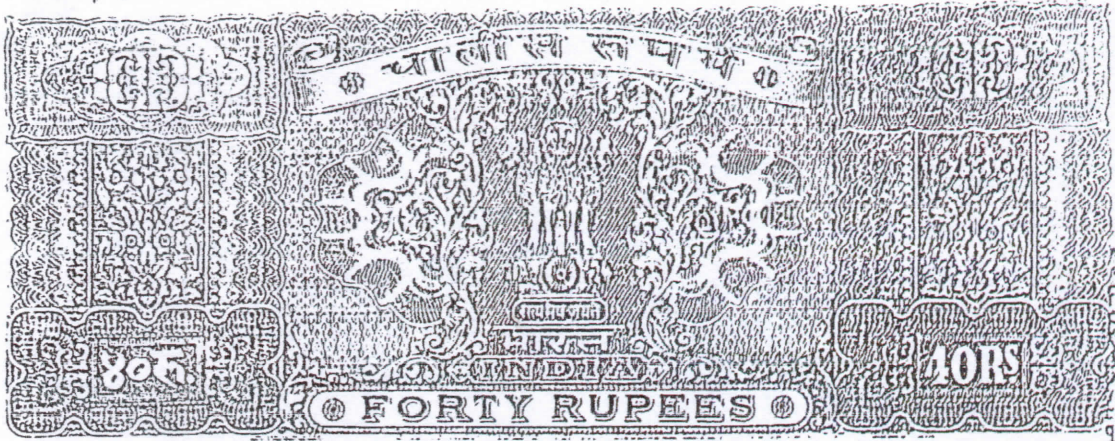

5. THAT the objects of the Trust shall be as follows :-

- (a) To take over the existing OIL VALLEY SCHOOL with all assets, liabilities, rights and obligations thereof and all furniture and fixtures belonging thereto if any to the said Trust and maintain and run the same by enlarging and enhancing its scope and standard with suitable accommodation and provisions for qualified teaching staff, getting recognition and help from the Government and strive for the all out improvement of the institution,
- (b) To establish, provide, carry on maintain and or assist in the maintenance of schools including Primary, Middle, High School, Higher Secondary School and Colleges for boys and or girls where students may obtain classical, cultural, physical, commercial, medical, technical, scientific and general knowledge of the highest order.
- (c) To provide for research work and for the delivery and holding of lectures, demonstrations, exhibitions, public meetings, classes and conferences calculating directly or indirectly to propagate and advance the cause of education.
- (d) To provide for, establish and maintain and run Libraries, Museums Societies, Lecture Halls and other institutions and to furnish the same with books, reviews, magazines, newspapers and other publications.
- (e) To collect and preserve old classical manuscripts, writings and literature of all kinds and paintings and sculptures.

- (f) To print, publish, distribute and sell, books, newspapers, magazines, pamphlets, brochures and other publications having its objects teaching, propagation, promotion and development of culture, literature, science and technology and to keep reserved the copyright of all or any of such publications for the Trust, if considered necessary.
- (g) To award, grant and present stipends, scholarships, prizes, medals, etc. study loans and other allowances and concessions to students, workers, writers, authors, editors and other interested persons in the advancement of education and culture.
- (h) To help needy persons whether victims of floods, epidemic, earthquake, war, civil disturbances or any other cause whatsoever with medicines, cloths, accomodations and rendering all other help in such manner as the Trustees shall from time to time think fit and proper.
- (i) To extend help and relief in the form of free distribution of medicine or giving aids or donations in money or kind to institutions, societies and other bodies of medical relief or for advancement of art and culture and for the overall mental and physical upliftment of the society in general.
- (j) To establish, support and maintain institution or institutions and societies intended to relieve poverty and distress such as Hospital, alms-houses, or orphanages, home for working girls, home for refugees, homes for disabled and crippled persons and helpless widows.
- (k) To establish, support and maintain institutions for promoting and spreading social consciousness among people.
- (l) To declare and give bonus, gratuities, pensions or other concessions and allowances to persons who are or were in the employment of the Trust or of any institution or institutions maintained and run by the Trust or the families or dependents of such persons.

- (m) To purchase, take on lease or hire or otherwise acquire any estate, land, building, easements or other rights or interests in immovable properties and all kinds of movable properties and to sell with the permission of the Court, let on lease or otherwise dispose of or grant rights over any real property or other properties whatsoever belonging to the Trust.
- (n) To collect, raise and receive subscriptions, donations and gifts in cash or in kind for all or any of the objects and to apply the same in accordance with the conditions, if any, presented by the donors and agreed to by the Trustees not beyond the objects of this Trust.
- (o) To borrow or raise money with or without security and on such terms and conditions the Trustees may think fit and proper for the purposes of the Trust.
- (p) To work for all or any other charitable purposes which may benefit the people in general provided always that and it is hereby declared that if any one or more of the objects specified above are held not to be for public charity, the Trustees shall not carry out such objects as if the same are not incorporated in these presents but the validity of the trust created by these presents as a Trust for charitable purposes shall not be affected in any manner.
- (q) To do all or such other lawful things as are incidental or conducive to the attainment of any one or more of the above or similar objects.

6. THAT any surplus of the capital or income of the Trust property which shall not be required or is not for the time being utilised for any of the purposes of the Trust or for payment of any costs or the expenses incurred on or about the execution of any of the objects of the Trust (except the money as the Trustee may think fit to deposit with any banker or bankers of the Trust as the Trustees may think fit to meet current expenses, shall be invested and kept invested by the trustee in such

7. THAT the first Trustees shall be the following persons :

8. THAT SRI SUNIRMAL BHATTACHARJEE, shall act as the Chairman and Managing Trustee during his life time until he voluntarily retires as Trustee.

9. THAT SRI SUNIRMAL BHATTACHARJEE as the Managing Trustee shall have the power to nominate his successor or successors from the existing Trustees or any other persons and the other Trustees shall be bound to accept and ratify the same.

THAT in case the aforesaid SRI SUNIRMAL BHATTACHARJEE fails to nominate his successor Managing Trustee, any other Trustee may be elected as Managing Trustee by the remaining Trustees for such time as may be determined by the Trustees and such Managing Trustee shall continue to act as such until another

11. THAT subject to general control and supervision of the Trustees, the Managing Trustee shall manage the Trust property and carry on all the affairs of the Trust and shall have all the necessary powers and authorities for the purpose held by the Trustees.

12. THAT the Managing Trustee shall have the power to delegate all or any of the powers under these presents to one or more of the other Trustees for such period and on such terms and conditions as the Managing Trustee may think fit.

13. THAT the number of Trustees shall not be less than Three and more than Seven. If the number of Trustees shall fall below the minimum the Trustees shall not, except for the purpose of filling up the vacancy, act so long as the number is below the said minimum.

14. THAT the Managing Trustee may at his discretion, and shall upon a requisition in writing signed by at least two Trustees specifying the object for which the meeting is desired to be convened, convene a meeting of the Trustees. If the Managing Trustee fails to hold such meeting within forty-five days the date of service of such requisition, the Trustees making such requisition may themselves convene a meeting of the Trustees but no business other than what is specified shall be transacted at such meeting.

15. THAT notice of the meeting of the Trustees shall be given to the Trustees one month before the date of the meeting. However in emergent circumstances the meeting may be held as the Managing Trustee may deem expedient and necessary.

16. THAT notice of the meeting of the Trustees and all other communications may be sent to the Trustees at their address registered for the time being in the records of the Trust.

17. THAT the meeting of the Trustees shall be held at such place or places as the Trustees may from time to time decide.

18. THAT One-Third of the total number of Trustees or two Trustees physically present whichever is higher shall form the quorum for the meetings of the Trustees.

19. THAT if within half an hour of the time specified for the meeting called, no quorum is formed, the meeting shall be adjourned to such time and place as the Trustees present may decide and notice of such adjournment shall be given to all the Trustees. In such an adjourned meeting even if no quorum is formed, the Trustees who are present may transact the business for which the meeting was called.

21. THAT all the questions arising at the meeting of the Trustees shall be decided by a majority of votes and in case of a tie, the Chairman shall have a second or casting vote.

22. THAT a Trustee who is unable to be present at a meeting of the Trustees because of his absence from the head quarters of the Trust may send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matters concerned.

23. THAT minutes of the proceedings of every meeting of the Trustees shall be entered in a Minute Book to be kept for this purpose and shall be signed by the Chairman of such meeting or of the following meeting and such minutes shall constitute conclusive evidence of the business and other matters transacted at such meeting.

24. THAT the Trustees shall be entitled to frame rules, add to modify and or alter the same from time to time as the circumstances may require for regulating their meetings and proper administration of the Trust.

25. THAT the Managing Trustee shall have the custody of these presents and of the books of accounts, Minute Book and other documents and or records of the Trust which shall at all times be open to inspection by any of the Trustees.

26. THAT the Trustees may appoint a Committee or committees or Sub-Committee consisting of such person or persons whether member of their body or not as they may from time to time think fit for any of the purposes of the Trust and may frame rules relating thereto and may from time to time add to and vary the same as they shall think fit.

27. THAT a resolution in writing circulated by the Managing Trustee amongst the Trustees and passed by a majority of the Trustees shall be as valid and effectual as if it had been passed at a meeting of the Trustees duly called and convened.

28. THAT for the furtherance of the objects of the Trust, the Trustees shall have the following powers :

- (i) subject to the directions and restrictions as contained in these presents, to apply the whole or part of the income of the Trust Fund and or Trust Property or accumulation thereof for any one or more of the objects of the Trust as the Trustees may in their absolute discretion from time to time determine;
- (ii) to employ clerks, and other employees, agents, brokers, bankers lawyers, accountants, auditors and others and at such remuneration as they think fit;
- (iii) to delegate any powers to one or more of their body;

- (vi) and generally to do all acts that may reasonably be necessary for carrying on the Trusts under these presents.

29. THAT the Trustees shall be entitled to open bank account with any nationalised bank or banks to which the Banking Regulations Act, 1949 (10 to 1949) applies as the Trustees shall in their absolute discretion think fit and such bank account shall be singly operated by the Managing Trustee or by his duly constituted attorney/s.

30. THAT the Trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect hereof in course of management of the Trust or in relation to the carrying out of the objects and purposes of the Trust as well as of all the assets, credits and effects of the Trust properties, and such accounts shall be annually audited by a Chartered Accountant.

31. THAT the accounting year of the Trust shall end on the 31st day of March each year or such other date as the Trustees may in their absolute discretion deem fit.

32. THAT all acts in carrying out these presents if done and carried out by a majority of the Trustees for the time being shall be as valid and effectual as if such acts had been done by all the Trustees.

33. - (d) if he is convicted of a criminal offence involving moral turpitude;

THAT the Trustees or any one of them shall be entitled at any time or from time to time to delegate all or any of his or their powers, duties and authorities under these presents to a Co-Trustee or Co-Trustees but however such delegation shall not mean and include the power to act as a proxy in a meeting of the board of Trustees.

44. THAT the Trustees may join and co-operate with any trust or institution having allied or kindred objects upon such terms as they may think fit but shall not dissolve this Trust or amalgamate this Trust with any other trust.

45. THAT it is hereby expressly declared that no part of the income of the Trust shall be applied for any purpose outside India or for any purpose which is not a public Charitable
